



Education Edition Site Licence Agreement

Applicable to Education Edition releases 2.2 +

The MYOB Education Edition CD (the Program) and its supporting documentation are the subject of strict Copyright and Trademark protection. Any unauthorised use of this material is a breach of Australian Federal law. The licence to use the Program is granted solely to the prescribed educational facilities and is subject to the terms and conditions set forth in this licence.

1. Installation

The Program will be installed and operated solely in the educational facility registered and shall only be used for educational or instruction purposes.

2. Number of users

MYOB Australia Pty Ltd hereby grants you, the applicant, a licence to install and use the MYOB software contained on the Program CD on an unlimited number of computers or computer terminals at the one site or campus.

3. Copies

You may not copy or duplicate the Program, except as necessary for backup or archival purposes, or to replace defective storage media, provided you keep any copies. You may not alter, decompile or disassemble the program. You may not make copies of the User Guide or any other documentation accompanying the product.

4. Transfers

You may not transfer, sub-licence, lease or rent or lend the Program or the User Guide or otherwise transfer any of your rights under this Agreement.

5. Support

The Program includes one year of free Technical Support, commencing the date the order is processed. You agree that all product usage and application questions from individual users will be directed to the Support Co-ordinator selected by you. MYOB Australia Pty Ltd is not obligated to respond to enquiries from anyone other than the designated 'Support Co-ordinator' or 'Support Co-ordinator 2'. You agree that direct support of or contact with the individual users of the Software is beyond the scope of this agreement. The level of support within the scope of this licence is limited to operational questions by telephone/fax and does not cover questions of an accounting nature.

6. Terms

The Licence granted in this Agreement is effective for twelve months from the date of issue. You may terminate it at any time by destroying the Program, or by returning them to MYOB Australia. If you fail to comply with any term or condition of this Agreement, this Licence will terminate and, upon any such termination, you agree to destroy the Program and User Guide, together with all copies, or to return them to MYOB Australia Pty Ltd. Termination of this licence shall be in addition to and not in lieu of any other remedies available to MYOB Australia Pty Ltd.

7. Protection and Security

You agree to use your best endeavours and to take all reasonable steps to safeguard the Program to ensure that no unauthorised person has access to the product and that there is no unauthorised copying or distribution of the Program.

8. Updates and Communications

You agree to receive all updates in respect of the Software, as required from time to time, by electronic download from the MYOB website. MYOB at its discretion may elect, from time to time, to distribute updates by other means. You agree to receive all communication related to the Software by email to the email address nominated in the Order Form. It is your responsibility to notify MYOB of any changes to the email address specified on the Order Form. MYOB at its discretion may elect, from time to time, to communicate with you by other means.
